

ORDINANCE NO. 11-16 of 2009

AN ORDINANCE OF SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY PENNSYLVANIA, REPEALING ANY AND ALL ORDINANCES WHICH PERTAIN TO DOGS TO INSURE THAT THE PENNSYLVANIA DOG LAW (3 P.S. §459-101 et. seq. as amended) IS THE EXCLUSIVE LAW APPLICABLE TO DOGS IN SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY, PENNSYLVANIA.

SECTION 1. Purpose. The purpose of this Ordinance is to repeal any and all ordinances enacted in South Buffalo Township, Armstrong County, Pennsylvania that pertain to dogs to insure that the Pennsylvania Dog Law, 3 P.S. §459-101 et. seq., as amended is the exclusive law applicable to dogs in the said township.

SECTION 2. Authority. This Ordinance is enacted pursuant to the applicable provision of the Second Class Township Code.

SECTION 3. REPEALER. Any and all Ordinances which pertain to dogs be and hereby are repealed. The only law in South Buffalo Township that will be applicable to dogs is the Pennsylvania Dog Law.

SECTION 4. SEVERABILITY. Should any portion of this Ordinance be declared unlawful for any reason whatsoever, it shall not affect any of the remaining provisions of this Ordinance.

SECTION 5. EFFECTIVE DATE. This Ordinance shall be effective immediately.


